MINUTES OF MEETING OF THE ENGLISH CARPET BOWLS ASSOCIATION HELD ON SATURDAY 12 JANUARY 2008

Present: Chairman, Vice Chairman, Secretary, Treasurer and representatives from Cambridgeshire, Durham, Essex, Hertfordshire, Northumberland, North Tyneside, Suffolk, Sunderland

1. Apologies for absence

2. Minutes of last meeting

Agreed and signed as a true record with the amendment that the Rule Book on Bowls was first produced in 2000.

3. Matters arising

(a) English Pairs

The Secretary spoke to the Norbeck Castle in Blackpool and obtained details of the possibility of the ECBA running an English Pairs at this venue. The dates available would be September 2008 and April 2009.

The Vice Chairman said that he had spoken at length to member from T & D who now run competitions at Seacroft, Hemsby in April about the time that Meld Leisure ran the English Pairs and the April 2009 date would clash with their event. It was suggest and agreed that the Vice Chairman approach T & D to see if they would work in conjunction with the ECBA to organise the English Pairs.

An event in Blackpool would not be pursued until we see what develops with T & D.

(b) <u>Referees courses</u>

Mr Russo has been unable organise any training courses.

Due to pressure of work, he will be resigning as Referee at the AGM in June 2008. The Chairman and Committee wish to express their sincere thanks to him for his work on behalf of the Association.

(c) ECBA Website

It was suggested that Paul Daniels from Suffolk be approached to take over the administration of the website.

Short Mat International

5. Secretary's Report

Books on Bowls Website

To date I have received about 10 requests for a copy of the Rules for Playing Carpet Bowls including Canada, Australia, Devon, Lincolnshire, Scotland.

The English Indoor Bowling Association requested a copy and reciprocated with a copy of their year book.

Its times like this that a Development Officer would be useful. Scotland, Devon & Lincolnshire would certainly be areas for development. Perhaps we could produce a 'welcome to carpet bowls' pack. A lady from Essex is looking for information. I have indicated that I would pass her address to our Essex representative and ask is someone could contact her and offer assistance.

ECBA Contract with Norbreck Castle

Whilst at the championships in November I took the opportunity to speak to the management of the hotel regarding

(a) A Pairs Competition (details circulated)

(b) Prices for 2011 and 2012 Champion of Champions and National County Championship. Our present contract is rolling and after 2 years of competitions at this venue it seemed an appropriate time to discuss the next 2 years.

The price for 2011 will remain the same as 2010 but we will not receive free places (1 for every 41 booked). At present the free places are taken by the officials who pay their money into the ECBA.

Date for County Championship for 2008

There seems to be some confusion on the date for this event. The list I circulated earlier was taken from copies of The Norbreck Castle contracts held by the Chairman. When this was queried after the document of dates was circulated, I e-mailed the hotel and asked for the date they have on file for the Championship. The date they gave me (without any prompting on my part) was the date circulated.

6. Treasurer's Report

Community Account - £404.19 Business Premium Account - £1248.60 (for development of bowls) Business Reserve Account - £13,232.19 In Total - all accounts - £14,884.98

Income from National County Championships - £547.50 from raffle, Pairs competition £32.00 and £540 from free places. The amount of the subsidy from the hotel is not yet available.

Expenditure - travel subsidy £4048. Hertfordshire and Northumberland have not cashed travel subsidy cheque.

South Tyneside are unable to host this tournament. Chairman indicated that Northumberland may be interested. Details later.

12. Bowls Alliance

Mr Alan Whitworth, the representative on behalf of the Alliance was unable to attend the meeting due to illness.

A document was circulated by the Chairman which he received from the Alliance. The Chairman spoke to Mr Whitworth on the telephone about the contents of the document, the details of which are as follows

- Cost - Only cost at the moment seems will be payment for 1-3 representatives from ECBA to attend 3 meetings a year (at Melton Mowbray)

- No written agreement on what he is telling us.

Why do they want us to become members - So they can speak as one voice to Sports England.
Will they have benefits that would be of interest and available to everyone, e.g. insurance (public liability, officers, equipment).

To move carpet bowls forward, a ballot agreed that officers would attended the next meeting of the Bowls Alliance on 27 March 2008. (6 votes for and 1 against)
