CHAIRMANS REPORT

Welcome to the 17th AGM of the Association the third one at this venue.

As we did last year I will let the secretaries report cover the detail of the competitions and restrict my comments to other matters.

Firstly a very sincere thank you to every county and individual who has supported the ECBA over the last year, we hope for your continued support in the future.

As ever my personal thanks go to the officers and delegates on the committee all of these people deserve not just my thanks but yours as well for all the work they do throughout the season.

All of the County delegates should be fully up to speed on everything that has happened at our meetings since the last AGM so I will not need to go into detail during this report, if anyone has concerns or questions they can be dealt with during AOB.

This year due to work and family commitments two officers have decided to stand down from their positions the referee David Russo and the Vice chairman Jamie Smith both from Cambridgeshire, I would like to take this opportunity to thank them both for their efforts on behalf of the ECBA.

There have been some encouraging signs over the past year that more people in different areas are becoming interested in our game, whether the numbers will be significant enough to form counties etc remains to be seen.

On the promotion front we have not done as much as I would have liked, two things that we need to push on with are the new promotional leaflet and the website. We are still without development officers both North and South, we intend to clearly define the role in the coming months and hopefully encourage someone to take on these positions.

As we look forward at what lies ahead, child protection is high on the agenda for us to deal with and you will be kept informed of any progress on that front, incidentally this will probably be relevant to clubs and counties as well as the ECBA.

As the credit crunch and fuel prices continue to pressurise people we would be naïve to think that the effects would not have an impact on carpet bowls the cost of venues at all levels are likely to rise significantly as organisations seek to pass on increases. Travel expenses for attending meetings will much higher, the cost of coaches and car travel to Blackpool will also be hit very hard. The natural thing for people to do when times get hard is to cut back on non essentials, unfortunately we all have to face the fact that our competitions could fall into this bracket and leave us facing a double whammy having hired the venue and then finding there are not enough entries to make it viable.

On the other hand people could see that coming to the competitions would be a welcome relief from the doom and gloom, I hope this is the case.

Can I thank Durham for the loan of the carpets and equipment and ask you to treat it with respect.

We wish all competitors the best of luck and hope you enjoy the weekend.

Remember at the end of play on Sunday it would be nice if there were plenty of volunteers to roll up the carpets.

Treasurers Report AGM 2008

This year I am happy to report that our combined Bank Balances have improved since this time last year by approx £2000.00. This is very encouraging having incurred the new expense of Insurance last year and Solicitor Fees, as well as refunding Raffle contributions and the one off payment of £500.00 to every County.

On the Income side our commission from the Norbreck was up, with those Officers who receive Free places from the hotel paying the cost of their accommodation direct to the Association. Our week at Potters continues to be a very good source of income for us, with the number of bowlers staying more or less at the same level.

The Expenditure is very much the same for Administration and meetings but I was able to find a new company for Insurance and that cost has reduced by over £270.00. The Champion of Champions does not include this years Trophies as they were not delivered to me until after the year end for these accounts. Unfortunately we incurred a loss at the ECBA Triples last September due to the high cost of hiring the venue in Sunderland. Finally, on expenditure, the travel subsidy to the County Championships increased this year because we no longer ask the counties to pay £1.00per mile for the first 100 miles of the total mileage.

I wish to express my thanks to Mrs Sue Withell, my Auditor, who has signed these accounts as a true record.
