

# MINUTES OF MEETING OF THE ENGLISH CARPET BOWLS ASSOCIATION HELD ON SATURDAY 17 JANUARY 2015

## 1. Apologies for absence

#### 2. Minutes of last meeting

The minutes of the meeting held 16th August 2014 were agreed and signed as a true record.

#### 3. Matters Arising from previous minutes

- Demonstration of carpet bowls at Whitehaven was successful with 1 set of carpet bowls being purchased
- b) Demonstration at a Manchester care home could provide carpet bowls at 6 further care homes although cost of equipment may be an issue.
- c) It would be beneficial for all carpet bowls websites to have links to each other
- d) Enquiries being received for suppliers of equipment and trophies to have links to their websites, currently the ECBA does not support this form of advertising. This will need to be reviewed and agreed at an AGM if we decide to allow advertising links.
- e) Carpet bowls in Norway appears to be growing in strength with significant investment to provide halls the ability to play. Norway and Sweden recently played a friendly tournament with 48 teams. Talk about staging international match is in its early stages. A contingent of players from Norway coming to UK on 8th Feb to play a friendly at Colmworth Village Hall in Bedfordshire. The Chairman is working on advertising this to its potential to get some much needed exposure.

# 10. Review of National County Championships 2014

The raffle had raised £492.00 – The Chairman commented on how well the competition went. There were some initial problems with the equipment but this was resolved prior to the commencement of the event. Although one mat still did have mixed woods. It was commented by Suffolk that the mats did not appear to play particular well unlike previous years and that more time should be set aside to ensure the best

possible position of the mats. The Chairman to work with the referee to ensure that the set up and testing of mats is done as early on Friday as possible; obviously this does require volunteers to make themselves available.

Cambridgeshire commented that the standard of food was below Potters normal standard in particular the Salad Bar.

## 11. Champion of Champions 6/7 June 2015

The Champion of Champions weekend would be held at Wolsingham as per last year's arrangements. The Treasurer asked that if a deposit is required then this is communicated as soon as possible.

The discussion regarding travel expenses was discussed. The Vice-Chairman commented that the association is not in a position to approve such expenses as the event currently makes a significant loss and would be against this. It was voted on and all those present were against travel expenses for the champion of champions

ECBA Triples held on the 14<sup>th</sup> September 2014 held at Braintree Leisure Centre and hosted by Essex went well, there were some observations made that the organisers should be aware of

- Lack of numbers
- Lack of advertising
- Lack of helpers to set up
- Programme changed to many times without notification

The Chairman applauded the winners of the 2013 event who travelled down to defend their title

ECBA Triples 2015 is being held on Sunday 20<sup>th</sup> September by Durham, entry forms will be available in due course
