The Minutes of a Committee Meeting of the Suffolk Carpet Bowls Association held at Needham Market Community Centre on Monday 27th November, 2000

The Meeting commenced at 7.30 p.m.

- Apologies were received from Margaret Southgate, Sally Goodrich, Andy Gilder and Richard Sago.
- 2. The Minutes of the previous meeting were approved and signed.
- 3. <u>Matters Arising:-</u>
- a) Referring to minute 8c (viii) of the previous minutes, Richard Sago, in writing expressed an opinion that he felt that members of different clubs should not join together to play in the County Closed Championships. It was however, pointed out that this had been clarified at the previous meeting and that this is not a Club competition and the rules do not forbid any combination of players playing together.
- 4. The Chairman's Report.

The Chairman had nothing to report that would not be covered by other officers later in the meeting.

- 5. <u>Secretary's report:-</u>
- a) The Secretary reported that she had received the following correspondence:-
- (i) Following on from 5b of the previous minutes regarding a letter from Martlesham C.B.C. a further letter had been received from them referring again to late cancellation of fixtures. The Committee again confirmed that no rule had been broken as 24 hours notice had been given. John Varden suggested that if this Club was unhappy with the rule as it stands they should perhaps propose a resolution for the A.G.M. to change this. The Chairman reminded the meeting that this was the only complaint that had arisen with regard to late cancellations and changes cannot be expected to be made in a case such as this and that he would recommend that the rule is not changed.
- (ii) A letter had been received from Pinewood Community Project regarding its proposal to build a Community Hall asking if the County C.B.A. would support, in writing, a Carpet Bowls Club which they hoped to set up. It was felt that we should reply offering any help with the setting up of a Carpet Bowls Club but only as we would with any new Club that is being formed.
- b) New Clubs: The Secretary reported that one new Club had joined the Association. This is Cratfield Social Club in the North of the County. Rita Daniels reported that this same Club had joined the Heritage League with a view to participating in Tournaments both in the Heritage and County but not in league fixtures.
- 6. Press Officer's Report.
- a) Sally in her absence had sent a message to report that the Joe Rice Cup and the Chairman's Plate were both well under way.

b) Rita Daniels asked if the County would like their league results posted on the web site which had been set up by the Heritage Coast League Fixtures Secretary. This was agreed. - b) Raffles:- Judith Longman requested that in future, the committee members running the various venues for Closed Championships would purchase the prizes so as to avoid the transportation of these. It was pointed out that this was already being done at the Leiston venue. Thanks were expressed to Judith and Margaret Southgate for the time they had spent buying prizes in the past. Judith pointed out that they would continue to buy the raffle prizes for other events.
- c) County Pairs Closed Championships:-
- i) <u>Moreton Hall:-</u> Arvon Evans asked that this meeting records a minute regarding the great help they receive from Peter Curtis and Bob Mallion.
- ii) <u>Leiston:-</u> Rita Daniels also mentioned how helpful the staff at Leiston are to the degree that a phone call is received the day before an event to inquire of the needs for the day of the tournament.
- iii) <u>East Bergholt:-</u> Concern was expressed with regard to the refreshments on offer. It was pointed out that the person who usually supplies the food at this venue was indisposed and that the management had supplied the refreshments on offer on this occasion.
- iv) Stowmarket:— Again refreshments were not available at this venue until lla.m. Our requirements in the future have been confirmed yet again by our Secretary on our part and by their catering manager, so that in future there should not be any confusion regarding the time that these are on sale. Lighting at this venue is very poor from 3p.m. It was pointed out that this could, along with the long wait between games, be resolved if Clubs are willing to supply more sets of equipment. This would enable one group only to play on each mat.
- v) John Varden commented on teams only getting two games due to the failure of teams to appear on the day and said that this was not good enough. The Committee felt that this was beyond their control and were told that those who did not turn up were being dealt with by their own Club Members.

CAPTAINS REPORT

Sunday 26th November saw the Suffolk team take on Bedfordshire in the first game of the 2000 – 2001 Eastern Counties League Season.

The team arrived at Barton Le Clay to the usual friendly greeting, coupled with a cup of tea and a biscuit to get us off to a good start.

The Suffolk Team for this match sported some new faces, being players who had come through from the trials. Being their first outing I am sure there were a few butterflies amongst them.

The first session was very tight with the hosts playing some determined bowls. I could quite see why Cambridgeshire only managed a draw here last season. However Suffolk held their game together, ending the session all square at 4 points for each County. The games we lost were by only one shot at, 6-7 & 9-10, the games we won were also tight at 7-4 & 7-6.

The second session was a better one for Suffolk as we managed to win it by 6 points to 2. The third session was halved with 2 points for each side.

In the fourth session Suffolk showed their true style, winning all 8 points and the shots margin this time was much greater.

The team continued their winning way in the final session dropping only one point and that on the final end of the game. The score in this session was 7-1. Making the final result Suffolk 27 points Bedfordshire 9.

Suffolk 163 shots Bedfordshire 99.

All in all a good result for Suffolk, and particularly pleasing as the new players fitted in well, playing their part in the win and importantly not letting themselves or the team down. Well done team.

EASTERN COUNTIES LEAGUE SUFFOLK V HERTFORDSHIRE

The latest match in the league was against Hertfordshire at Potters Bar. Where Suffolk needed as many points as possible after the defeat by Norfolk to stay on top of the league and possibly go on to take the title.

The Match followed the usual format using 4 mats and playing over 5 sessions with each rink playing 3 games.

In the first session Suffolk won 2 games halved 1 and lost the other.

The second session was much the same as Suffolk won 3 games and lost the third, it was becoming obvious that Hertfordshire had improved their team since our last meeting and were not about to give us an easy passage.

The third session where only two teams compete worked out better for Suffolk as they won both of them. It was still a close call, as the scores in those games were 9 Points to 7 and 8 Points to 7.

The forth session was even as both teams won 2 games

In the final session Suffolk managed to win 3 games and lose 1

Suffolk 25 Points and 167 Shots

Hertfordshire 11Points and 124 Shots

On the same day Norfolk were playing Essex and drawing 18 - 18 and Cambridgeshire were playing Bedfordshire also drawing 18 - 18. This meant that Suffolk were still at the top of the table.

The last batch of games, to be played on Sunday 9th April sees Suffolk take on Cambridgeshire, Norfolk play Bedfordshire and Essex against Hertfordshire. It promises to be a tense weekend.

CAPTAINS REPORT

The English County Championships for 2000 were held at Seacroft Hemsby on the weekend of the 4th to 5th of November.

Competition actually began on Friday evening with the Northern League represented by Durham playing against the Southern League represented by Norfolk. In 1999 Norfolk won this encounter, but this year the tables were turned and Durham took the trophy home.

Saturday morning saw the competition proper start. Of the ten member counties only Bedfordshire were unable to field a team. Each county team consisted of six rinks A to F, who then played off against the equivalent rink from all the other counties. The competition is played on 12 mats and 9 sessions each of the two days.

Suffolk got away to a flying start against South Tyneside winning all 3 games. We then had to play Hertfordshire who are improving all the time and managed to collect 3 points. Next came North Tyneside 4 points, Northumberland 6 points, Essex 6 points and Cambridgeshire 4 points. This left Norfolk and Durham to be played in our last two sessions on Saturday. Unfortunately we were unable to keep the momentum going and scored only 2 points in each session, making a total of 33 points from day one of the tournament. If we could repeat this form on the second day then we were in with a chance of taking the title.

Sunday arrived and once again Suffolk were up and away, winning all 6 points against South Tyneside. Hertfordshire went the same way 6 points again to Suffolk. A further 4 points were taken from North Tyneside, things were looking good for us. Next to play was Northumberland who normally have a good first day and an ordinary second day. This time however it was the other way round, as we only managed 2 points. The 4 points from Essex in the next session restored things a bit, only for us to falter again against Cambridgeshire and take just 2 points. We then managed 3 points against Norfolk and 4 points from Durham, making a total of 31 points for day two.

In the competition format, each county has to sit out in one session each day, and unfortunately our blank session was the last one on each day. So having reached the last session we now had to sit and wait.

Going into the last session we had 64 points, Durham 61 and Cambridgeshire 60. Durham then took 4 points from Hertfordshire and Cambridgeshire took all 6 points from South Tyneside. Making the final scores, Cambridgeshire 66 points, Durham 65 points and Suffolk 64 points.

Taken all round it was a great competition with some wonderful bowls being played and we should be proud of our players for coming so close to pulling it off.

The only real problems with the weekend are the fact that the session scores are not posted quickly enough and that there is sense of occasion generated at the beginning of the competition, nor at the end for that matter. For what is after all the meant to be the top competition in the carpet bowls calendar, I feel that this is a great pity.
