- 5. Chairman's Report:**
AG: Welcome back everyone, I hope you all have had a good Christmas and New Year, ate plenty, drank lots and had some rest and relaxation.
We now have to start again and make 2026 another successful year.
The end of 2025 was difficult for our county team, with a narrow win over a determined Cambridgeshire team and a narrow loss to an up-and-coming Hertfordshire team. An unusual position for Suffolk but the league is still there to be won, which we will be fighting for tooth and nail. I'm sure Sally will be reporting more on this later.

A good showing for the Suffolk fours was won by a good Chelmondiston team. The Suffolk Triples was won by a good Belstead team. Many congratulations to the winners and well done to all that competed in the competitions to make them the success they were.

7. Treasurer's Report:

PD: Accounts to date -

We are currently showing a surplus of just under £2000, although adjusting for the money we've had in so far for the Charity Fours, brings that figure down to £1400. That doesn't mean we are going to end the year that way, most of our income for the financial year is already in, and most of that current surplus will be eaten up in the back half of the year by trophy and hall hire costs. With that said, the figures are exactly in line with where we were at the same time last year.

The Triples recorded an overall profit of £217.

Hall Hire

At the tail end of last year, we were advised by the Hall that the hiring fees would be going up at the start of 2026:

All day £250 to £280
Evening £100 to £104
Meeting £29.50 to £31

While the other increases are not too bad, the cost of hiring the hall all day will hit us the hardest, and will cost us at least an extra £250 per year, although since we're already halfway through our financial year, the impact won't be as great this year.

As usual, we have to acknowledge that the hall's central location, the fact that it's big enough to enable us to use up to 9 mats, and that they allow us to store our equipment here, means that moving to another venue does not seem like a viable option, so we will simply have to find a way to mitigate against the increased costs.

AG added that on the letter from Needham Market Community Hall, they request risk assessments, safeguarding and public liability insurance. **PD** confirmed that they may ask for them and that we have them in place if needed.

SG asked if we pay extra for the kitchen as it is in a bit of a state. **RS** said we don't and that he does feed back to the committee.

8. Match Secretary's Report:

That game was followed by a visit to Hertfordshire, which was always going to be tough. Having started well, Suffolk lost all 3 games in the third session of the day, and never recovered. The match ended in a 21-15 loss, which, again, might have been quite different if not for another couple of games which went begging by just a single shot.

That leaves Suffolk fourth in the league, behind Essex, Cambridgeshire, and Hertfordshire. We will need to make the most of our trip to Bedfordshire on the 18th January.

We then play away again on the 15th February to Essex and our last match at Home to Norfolk on 15th March,

I believe the best is yet to come.

13. Inter-code competition

not.

SG: Ally played some outdoor bowls and said to some players about carpet bowls and three players are now playing carpet bowls when they can't play outdoor.

SCG: Would it be socially or as a competition. **AG** felt it should begin socially. If it is agreed to go ahead then a discussion would be had about how to move forward.

SG also added about the need for equipment for indoor bowls.

AH said it was a good idea and worth ago.

PD agreed and said that them transitioning from indoor to carpet is easier.

NJ added that he could only see a gain from it and that bowlers would naturally want to have a go. If it's agreed it's a good idea, we can take carpet bowls over to them and do both on one day; considering the format to make it work.

RS shared that they have a couple of outdoor bowlers that play for Burstall and that it works well. All other committee members agreed it was a good idea and worth a go.

AG confirmed that the next step is to contact the Chairperson of Rushmere Indoor Bowls club to make an appointment to discuss ideas with them. **AG** asked that in the meantime, committee members thought about and suggested any ideas they had.
